

Congressional Week Ahead

June 21-25, 2010

The Senate may try once again to finish the tax extenders bill, but it is looking increasingly likely that it may be put aside for the time being. Conferees are also trying to finish work on the Wall Street reform bill by Thursday so that the conference report can be passed by both chambers in time for July 4th recess. The House also continues to negotiate on budget legislation, which is expected to include a one-year deeming resolution to set discretionary spending levels for FY2011.

Tax Extenders

After Senate Democrats failed to reach cloture late last week, much of the legislation remains in limbo. The Senate did pass a six-month Medicare physician payment fix by unanimous consent, which the House must now consider even though it is significantly shorter than the House-passed payment fix of 19 months. Also lingering in the Senate is the \$24 billion in additional federal Medicaid funding for states, which may put many states in a bind as state fiscal years often begin in July.

House Floor

House members will not be in session on Monday and will return Tuesday at 12:30 pm. It is expected that the war supplemental will be hitting the floor for debate and hopefully a vote sometime this week, although House Speaker Pelosi did not commit to finishing the bill before the July 4th recess. The House version of the supplemental totals \$84 billion, including \$33 billion for the wars in Afghanistan and Iraq. Although the current version also has \$23 billion to prevent teacher layoffs, this funding may be scaled back to \$10 billion due to concerns over deficit spending.

It is also possible that a campaign finance bill will be brought for a floor vote sometime this week. Sponsored by Rep. Chris Van Hollen, the bill would move to impose tighter donor disclosure rules on corporations, unions, and other groups who have recently been allowed to buy unlimited television spots by the Citizens United v. FEC ruling. Democrats are still working to unify their caucus around the bill, even though some are



angered over carved-out exemption for the NRA that would permit them to not disclose their top donors to political ads.

Senate Floor

The Senate returns on Monday at 2 p.m. to consider the nominations of Mark Goldsmith to be U.S. District Judge for the Eastern District of Michigan; Marc Treadwell to be U.S. District Judge for the Middle District of Georgia; and Josephine Staton Tucker to be U.S. District Judge for the Central District of California.

It is still possible for tax extenders to return to the floor, but if not the Senate is expected to instead consider a small business lending and tax incentive bill, a FAA reauthorization measure, or a collective bargaining bill for public safety workers. Senator Tom Harkin also expressed hope that a repeatedly delayed food safety bill would receive some floor time. The bipartisan bill would give the FDA new powers including the ability to issue a mandatory recall on food products.
