

Congressional Week Ahead June 28 – July 1, 2010

This week, the House and Senate will take up the financial regulatory reform conference report on the floor. The Senate Judiciary committee also begins hearings Monday on the nomination of Elena Kagan to the Supreme Court. The Senate, having pushed aside tax extenders for the time being, begins work on a small business lending and tax incentive bill.

Financial Regulatory Reform

After two weeks of conference negotiations, both chambers hope for final passage on the regulatory reform bill before the weeklong July 4th recess. The bill includes the "Volcker Rule" language, which would prohibit banks from proprietary trading for their benefit and would prevent them from investing more than 3 percent of their Tier 1 capital in hedge funds or private equity. The bill also includes the establishment of an independent Consumer Financial Protection Bureau, and compromise language sponsored by Sen. Blanche Lincoln that cracks down on the \$600 trillion derivatives market.

War Supplemental

House Appropriations Chairman Obey had unveiled a \$84 billion package last month, but scalebacks are likely if it is taken up on the floor this week due to push-back from House Democrats on deficit spending. Some are looking to reduce the \$23 billion meant to prevent teacher layoffs to \$10 billion and offset the spending with unspent 2009 stimulus funds. The Senate passed a \$59 billion supplemental bill last month that did not contain any teacher funding.

Energy and Climate

Postponed last week from his meeting with General McChrystal, President Obama meets this Tuesday with a bipartisan group of senators to talk about moving forward energy and climate legislation. Majority Leader Reid has been saying he will bring some type of clean energy bill with an oil spill component to the floor in July. But despite a reportedly enthusiastic Democratic caucus meeting last week, many of the more skeptical Democrats were not in attendance and there was little evidence uniting under specific legislative proposals. Tuesday's meeting is expected to include Republican Sens. Graham, Lugar, Murkowski, Gregg, Collins, and Voinovich.

House Floor

The House returns on Monday at 12:30 pm for consideration of eight suspension bills, with 18 other suspension bills to be voted on throughout the rest of the week. The chamber is also expected to vote on final passage of H.R. 4173, the financial regulatory reform conference bill. The House version had originally passed by a 223-202 vote, with no Republicans expected to vote for its final passage. Speaker Pelosi stopped short of committing to further action on H.R. 4899, the war supplemental appropriations bill, but action this week remains a possibility.

Senate Floor

The Senate returns on Monday at 2 pm and will consider a small-business lending and tax-incentive bill, with a cloture vote scheduled for later in the afternoon. The legislation will be in the form of a substitute amendment to the House-passed version, containing popular bipartisan provisions such as \$12 billion in tax breaks and the establishment of a fund to spur lending to small businesses by community banks. While most of the provisions are relatively uncontroversial, the measure could still be slowed down from the unrelated issue of the estate tax. The Senate chamber will then proceed with an executive session to consider nominations.

The Senate is also expected to take up the financial regulatory reform conference report sometime in the week. The earlier Senate version of the bill had passed 59-39, but a few more Republicans may end up voting in favor of the final bill.
